## Local Wellness Program

The district's comprehensive age-appropriate nutrition program will be implemented in district schools in accordance with the following requirements:

### Definitions:

1. "Competitive foods" means any food or drink sold in competition with the National School Lunch Program (NSLP) and/or School Breakfast Program (SBP) in food service areas during the meal periods;

"Dietary Guidelines for Americans" means the current set of recommendations of the federal government that are designed to help people choose diets that will meet nutrient requirements, promote health, support active lives and reduce chronic disease risks;

"Nutrition education" means a planned sequential instructional program that provides knowledge and teaches skills to help students adopt and maintain lifelong healthy eating habits;

"Foods of minimal nutritional value (FMNV)" means:

- a. In the case of artificially sweetened foods, a food which provides less than five percent of the Reference Daily Intakes (RDI) for each of eight specified nutrients per serving; and
- b. In the case of all other foods, a food which provides less than five percent of the RDI for each of eight specified nutrients per 100 calories and less than five percent of the RDI for each of eight specified nutrients per serving. The eight nutrients to be assessed for this purpose are - protein, vitamin A, vitamin C, niacin, riboflavin, thiamine, calcium and iron;
- c. Food that is classified into four categories:
  - (1) Carbonated soft drinks;
  - (2) Chewing gum;
  - (3) Water ices; and
  - (4) Certain candies made predominantly from sweeteners such as hard candy, licorice, jelly beans, gum drops, marshmallows, fondant, cotton candy and candy-coated popcorn.

"Food service area" means any area on school premises where NSLP or SBP meals are both served and eaten, as well as any areas in which NSLP or SBP meals are either served or eaten;

"Meal period" means the period(s) during which breakfast or lunch meals are served and eaten, and as identified on the school schedule.

## **Nutrition Education**

Nutrition education shall focus on students' eating behaviors, be based on theories and methods proven effective by research and be consistent with state and local district health education standards. Nutrition education at all levels of the district's curriculum shall include, but not be limited to, the following essential components designed to help students learn:

Age-appropriate nutritional knowledge, including the benefits of healthy eating, essential nutrients, nutritional deficiencies, principles of healthy weight management, the use and misuse of dietary supplements, safe food preparation, handling and storage and cultural diversity related to food and eating;

Age-appropriate nutrition-related skills, including, but not limited to, planning a healthy meal, understanding and using food labels and critically evaluating nutrition information, misinformation and commercial food advertising; and

How to assess one's personal eating habits, set goals for improvement and achieve those goals.

In order to reinforce and support district nutrition education efforts, the building principal is responsible for ensuring:

Nutrition instruction is closely coordinated with the school's nutrition and food services operation and other components of the school health program to reinforce messages on healthy eating and includes social learning techniques. To maximize classroom time, nutrition concepts shall be integrated into the instruction of other subject areas where possible;

Links with nutrition service providers (e.g., qualified public health and nutrition professionals) are established to: provide screening, referral and counseling for nutritional problems; inform families about supplemental nutritional services available in the community (e.g., food stamps, local food pantries, summer food services program, child and adult care food program), and implement nutrition education and promotion activities for school staff, Board members and parents;

### **Rewards**

Schools will not use foods or beverages that do not meet nutrition standards for foods and beverages to the extent possible as rewards for academic performance or good behavior and will not withhold food or beverages as a punishment.

### **Celebrations**

School parties should include no more than one food or beverage that does not meet the minimum nutrition standards for foods and beverages sold individually. The school district will disseminate a list of healthy party ideas to parents and teachers. The school district is requesting that all food and beverage products used in celebrations be commercially prepared.

7. Child Nutrition Staff support nutrition education by marketing healthy meals and providing nutrition information to students and families.

## **Physical Activity**

In order to insure students are afforded the opportunity to engage in physical activity in the school setting, the following guidelines apply:

1. Physical activity will be integrated across curricula and throughout the school day. Movement will be made a part of science, math, social studies, and language arts;
2. Physical education will be a course of study that focuses on students' development of motor skills, movement forms, and health related fitness;
3. Physical education courses will be the environment where students learn, practice and are assessed on developmentally appropriate motor skills, social skills, and knowledge;
4. All physical education classes will be taught by highly qualified physical education instructors; and
5. All elementary school students will have at least 20 minutes per day of supervised recess, preferably outdoors, during school hours. This recess should encourage moderate to vigorous physical activities through verbal instruction, modeling and provision of space and safe equipment. Should students participate in activities requiring long periods of time with physical inactivity, frequent breaks for stretching and moving around should be encouraged and provided.

## **Nutrition Guidelines and Food Services Operation**

In order to support the school's nutrition and food services operation as an essential partner in the educational mission of the district and its role in the district's comprehensive nutrition program, the building principal is responsible for ensuring:

The school encourages all students to participate in the school's NSLP and SBP meal opportunities;

The school notifies families of need-based programs for free or reduced-price meals and encourages eligible families to apply;

The school's NSLP and SBP maintains the confidentiality of students and families applying for or receiving free or reduced-priced meals or free milk in accordance with the National School Lunch Act;

The school's NSLP and SBP operates to meet nutrition standards in accordance with the Healthy Meals for Healthy Americans Act of 1994, as amended, and applicable state laws and regulations;

The school sells or serves varied and nutritious food choices consistent with the applicable federal government Dietary Guidelines for Americans. Schools contracting out the food service part of their NSLP and SBP shall form a nutrition advisory committee comprised of teachers, students and parents to assist in menu planning. A nutrition committee comprised of students, family members

and school personnel will be encouraged to provide input in menu planning for districts operating their own food service component of the NSLP and SBP (i.e., food services purchasing, menu planning, food production and meal service). Cultural norms and preferences will be considered;

Food prices set by the district are communicated to students and parents. District pricing strategies will encourage students to purchase full meals and nutritious items;

Procedures are in place for providing to families, on request, information about the ingredients and nutritional value of the foods served;

Modified meals are prepared for students with special food needs:

The district will provide substitute foods to students with disabilities upon written parental permission and a medical statement by a physician that identifies the student's disability, states why the disability restricts the student's diet, identifies the major life activity affected by the disability, and states the food or foods to be omitted and the food or choice of foods that must be substituted;

Such food substitutions will be made for students without disabilities on a case-by-case basis when the parent submits a signed request that includes a medical statement signed by a physician, physician assistant, registered dietitian or nurse practitioner. The medical statement must state the medical condition or special dietary need that restricts the student's diet and provide a list of food(s) that may be substituted in place of the lunch or breakfast menu being served.

Food service equipment and facilities meet applicable local and state standards concerning health, safe food preparation, handling and storage, drinking water, sanitation and workplace safety;

Students are provided adequate time and space to eat meals in a pleasant and safe environment. School dining areas will be reviewed to ensure:

- a. Tables and chairs are of the appropriate size for students;
- b. Seating is not overcrowded;
- c. Students have a relaxed environment;
- d. Noise is not allowed to become excessive;
- e. Rules for safe behavior are consistently enforced;
- f. Tables and floors are cleaned between meal periods;
- g. The physical structure of the eating area is in good repair;
- h. Appropriate supervision is provided.

11. The guidelines for reimbursable school meals shall not be less restrictive than regulations and guidance issued by the Secretary of Agriculture pursuant to subsections (a) and (b) of section 10 of the Child Nutrition Act (42 U.S.C. 1779) and sections 9(f)(1) and 17(a) of the Richard B. Russell National School Lunch Act (42 U.S.C. 1758(f)(1), 1766(a)), as those regulations and guidance apply to schools.

## **Other School-Based Activities**

The district will explore the following activities and encourage the following practices which promote local wellness:

1. Assemblies which focus on wellness issues such as obesity and obesity- related diseases, healthy eating, and the benefits of physical exercise;
2. The use of alternates to food as rewards in the classroom;
3. Limit the amount of foods with no nutritional value that are sold in vending machines; and
4. Support groups for students with eating disorders

### **Foods of Minimal Nutritional Value (FMNV) and Competitive Food Sales**

In keeping with federal regulations, the district controls the sale of FMNV and all competitive foods.

Though federal regulations permit FMNV to be sold in food service areas before and after school meal periods, and outside of food service areas at any time, district shall meet minimum state requirements. The District will encourage whole grains, low fat, and low sugar whenever possible.

Accordingly, the district will select from the following nutritional food items<sup>1</sup> offered or included in all such sales:

Canned fruits;

Fresh fruit (e.g., apples and oranges);

Fresh vegetables (e.g., carrots);

Fruit juice and vegetable juice, at least 50 percent full strength, and bottled water, within established district guidelines;

Low-fat crackers and cookies, such as fig bars and ginger snaps;

Pretzels;

Bread products (e.g., bread sticks, rolls, bagels and pita bread); encouraging alternative grain products.

Ready-to-eat, low-sugar cereals;

Granola bars made with unsaturated fat;

Low-fat (one percent) or skim milk;

Low-fat or nonfat yogurt;

Snack mixes of cereal and dried fruit with a small amount of nuts and seeds;

Raisins and other dried fruit;

Low-fat crackers.

The sale of all other foods, other than FMNV, in competition with the district's NSLP and SBP meals shall be permitted in school food service areas during school meal periods only when all income from the food sales accrues to the benefit of the district's nutrition and food services operation or school or student organization as approved by the Board.

### **Other Foods Offered or Sold**

The district recognizes that federal government standards requiring schools to provide NSLP and SBP meals consistent with applicable Dietary Guidelines for Americans do not apply to competitive foods sold or served outside the food service areas as defined in this regulation.

Foods offered in classrooms or school-sponsored activities and food and beverages sold as part of approved school fund-raising events shall meet minimum state requirements unless otherwise exempt by state law.

### **Staff Development**

Ongoing pre-service and professional development training opportunities for staff will be encouraged. Staff responsible for nutrition education will be encouraged to participate in professional development activities to effectively deliver the nutrition education program as planned. Nutrition and food services personnel receive opportunities to participate in professional development activities that address strategies for promoting healthy eating behavior, food safety, maintaining safe, orderly and pleasant eating environments and other topics directly relevant to the employee's job duties. The building principal is responsible to ensure such training is made available including, but not limited to, the following:

Personnel management;

Financial management and record keeping;

Cost- and labor-efficient food purchasing and preparation;

Sanitation and safe food handling, preparation and storage;

Planning menus for students with special needs and students of diverse cultural backgrounds;

Customer service and student and family involvement;

Marketing healthy meals; and

Principles of nutrition education, including selected curriculum content and innovative nutrition teaching strategies;

Assessment by staff of their own eating practices and increased awareness of behavioral messages staff provide as role models.

### **Family and Community Involvement**

In order to promote family and community involvement in supporting and reinforcing nutrition education in the schools, the building principal is responsible for ensuring:

Nutrition education materials and cafeteria menus are sent home with students;

Parents are encouraged to send healthy snacks/meals to school;

Parents and other family members are invited to periodically eat with their student in the cafeteria;

Families are invited to attend student activities;

Nutrition education is provided on the district web site and in the Parent/Student Handbooks

Nutrition education homework that students can do with their families is assigned (e.g., reading and interpreting food labels, reading nutrition-related newsletters, preparing healthy recipes, etc.);

School staff are encouraged to cooperate with other agencies and community groups to provide opportunities for student volunteer or paid work related to nutrition, as appropriate;

8. School staff encourages and provides support for parental involvement in their children's physical education;
9. Materials promoting physical activity are sent home with students in newsletters and on the district web site;

### **Program Evaluation**

In order to evaluate the effectiveness of the local wellness program in promoting healthy eating, increased physical activity among students and to implement program changes as necessary to increase its effectiveness, the superintendent or designee is responsible for ensuring:

Board policy and this administrative regulation are implemented as written;

All building, grade-level nutrition education curricula and materials are assessed for accuracy, completeness, balance and consistency with state and local district educational goals and standards;

Nutrition education is provided throughout the student's school years as part of the district's age-appropriate, comprehensive nutrition program;

Teachers deliver nutrition education through age-appropriate, culturally relevant, participatory activities that include social learning strategies and activities;

Teachers and school nutrition and food services personnel have undertaken joint project planning and action;

Teachers have received curriculum-specific training;

Families and community organizations are involved, to the extent practicable, in nutrition education;

8. Superintendent and principals within the local educational agency or at each school, as appropriate, will be charged with the operational responsibility of ensuring that the policy and administrative regulations are followed and will develop an evaluation plan to be used to assess the district's level of compliance with the requirements; and
9. Teachers provide physical activity instruction and programs that meet the needs and interests of all students.
10. Surveys will be sent out to parents, students, and staff regarding our local wellness program.

## HEALTHY CLASSROOM SNACK, PARTY FOODS, & BEVERAGE IDEAS

### SNACKS:

Assorted fresh fruits: such as apples, oranges, grapes, berries, bananas, pears, etc.

Assorted frozen fruits: such as blackberries, blueberries, strawberries, cherries, peach etc.

Assorted fresh vegetables: such as carrots, celery, broccoli, cauliflower, cherry tomatoes, lettuce, edible pea pods, cucumbers, etc.

Assorted fresh veggies with a healthy, low fat dip

Individually packaged canned fruit in fruit juice (low or no sugar added)

Dried fruits with no added sugar

Nuts: **ONLY IF NO STUDENTS HAVE ALLERGIES TO NUT & NUT PRODUCTS**

Trail mix – healthy variety.

Fruit and cheese kabobs

String cheese, or other low fat cheese strips/cubes

Low sugar fruit & yogurt parfaits, or fresh or frozen fruit & yogurt parfaits

Low fat/ low sugar puddings

Popcorn, low fat or air popped

Granola bars, breakfast bars: low sugar, low fat, with or w/o fruit

(Nut/ Peanuts, Peanut butter **ONLY** if **NO** students with **ALLERGIES TO NUTS**)

Low fat, low sugar cookies such as fig neutons or gingersnaps

Low fat crackers with cheese (&/or peanut butter if **NO Allergies** in classroom/ area.)

Whole grain bread, bagels, pretzels, or crackers (beware of excess salt)

Whole grain pizza

Quesadillas with salsa

Whole grain pita bread w/ veggie, meat, or cheese filling

Commercially prepared, low fat, low sugar salads, such as Carrot/raisin, Coleslaw,

Fruit, Egg, Potato, or other.

Frozen 100% fruit juice popsicles

Frozen low fat yogurt

Frozen bananas

### BEVERAGES:

Low fat milk

Low fat flavored milk w/ less than 30 grams of sugar in an 8 oz. serving

100% Fruit juice

Water
